#### Requirements

- 1. A cover sheet stating the following must be included:

  - Phone number and address of the person who will receive all correspondence.
- Sections A and B below describe the components to be addressed in writing. Ensure that the <u>written submission does not exceed</u>
   <u>the maximum number of 1000 words/3 pages</u>. You are encouraged to include any additional information that you feel will assist
   the judges (as long as it does not exceed the maximum number of pages permitted).
- 3. Submissions must be made on company letterhead using your company standard issue presentation covers.

# SECTION A: WRITTEN SUBMISSION

Your written submission should support the bullets below describe the components to be addressed in writing.

Ensure that the written submission does not exceed the maximum number of pages permitted (3 including the cover sheet)

Supporting documentation must be provided, demonstrating evidence on how the selection criteria have been achieved.

This documentation, when combined with the written submission, should not exceed the maximum number of pages permitted (3 including the cover sheet)

The following items are required as part of your Formal Entry package:

- $\bullet$  Submission must be in an 8 ½" x 11" resume format submitted in a PDF file (Submission
- should be limited to 2-4 pages, single or double spaced acceptable.
- Cover sheet stating the following must be included: Name of Entrant, Company, contact

phone number and email address

#### **SECTION B: QUESTIONNAIRE**

- Written descriptions to be submitted for each of the following criteria:
  - Leadership Skills demonstrated (this must include a letter from the local association describing these skills).
    (30 points)
  - Participation in BOMA- committee involvement; local, regional (national) or international. (30 points)
  - CRE Community Contribution time and impact to the CRE community. (20 points)
  - BOMA Education earned and/or delivered: professional designations, continuing education, seminars, conferences, instructor, panelist, subject matter expert (20 points)
  - Photograph: One color photo (minimum 300 dpi) electronic format (jpg).
